### **Stress 101** By:Emilio Azukwu





Written by James Weldon Johnson in 1900, the song came to be known as the Negro National Anthem when the National Association for the Advancement of Colored People adopted it as such in 1919. Ironically enough, the poem was first performed as a song in a tribute to Abraham Lincoln, who is still to this day celebrated by many African-Americans. The lyrics resonate with me as a force of resilience in the face of the adversities that come along with being Black in America. The poem means more to me as an anthem because unlike any other, I feel it was written with me in mind and not just coming to possess that meaning over time(or still not).

I believed that America was past the time where Jena 6 would be possible but I am no longer convinced of that, which makes the anthem forever relevant. History is forever repeating itself. That story left me extremely discouraged but the words of the anthem are about faith, pride and remembering those that came before us to create a world safer than it was for them, to live in and succeed without scrutiny. While we still have a ways to go, it is important to acknowledge the strides that have been made for our



#### The Miseducation of Las Guyaquilenas By:Nathalie Lafleur

On Tuesday September 25th, Sigma Lambda Upsilon hosted a presentation in sac 305 entitled "The Miseducation of Las Guyaquilenas" as part of RACIES WEEK 2007. The presentation focused on the quality of lives of the children in Ecuador. They focused on a foundation in Ecuador called the Carino foundation. This foundation is located in Guayaquil, which is a very poor area in Ecuador. The government funds this foundation. Mothers bring their children there from the ages of 5 months to 8 years old.

In Ecuador 70% of children are malnourished. According to a doctor in the foundation malnutrition is a frequent problem in Ecuador. The causes of malnutrition includes the lack of healthy foods, bad living conditions and young mothers who are not educated on how to feed their children healthy foods.

Zoila Sanchez, one member of Sigma Lambda Upsilon, visited the foundation while in Ecuador. While she was there she spoke to two foundation helpers who were present. They all had different things to say about the children in the foundation and the mothers. One helper noted that the children who come into the foundation are in need of healthy foods, like cereal and milk. When those children are at home, they are not fed properly. They are fed random things like water instead of milk, and fatty foods instead of healthy vegetables.

Another helper also noted that the mothers themselves are not eating healthy when they are pregnant. If the mothers are not eating healthy, there's a risk that the baby will be born malnourished. Even if the baby is born without any obvious health issues, the mother will have malnourished him/her, just by not giving them healthy food to eat. The helper mentions that healthy food is not expensive, but rather some mothers are negligent, meaning that instead of giving their children healthy food, they give them anything to eat.

The doctor at the foundation says that, the children are malnourished because the mothers are very young and they do not know how to take care of their babies. Also the mothers do not have jobs and they receive very little help from the government. Another reason why there is malnourishment is because the living situations are not very good. The people live in poor areas that are not very clean; and since the areas are not clean parasitic worms infect the children. The mothers cannot help the children get better because testing for parasitic worms is two dollars, but the mothers cannot afford to pay that because they are poor. Furthermore because the mothers live in poor areas, they cannot find good quality foods in their neighborhood to feed the children, so even If they wanted to or had the money, finding good quality food is hard.

Another point that they touched on at the meeting was the fact that malnutrition is not just a problem in Ecuador, it is an international problem. It occurs in places like Africa and South Asia. One other interesting thing that was brought up was that malnutrition happens in the United States as well. Fast food restaurants like McDonalds and Burger King, that do not promote healthy eating, dominate the poor neighborhoods in the United States and most of the time that is all some parents let their children eat.

Red, red, red. It is Red-hot everywhere. There are sports Jersey's, helmets, and the Wolfie mascot all over the newly renovated Wolfie's Restaurant, located up stairs in the Union. Talk about school spirit. It is a great environment where students can enjoy a variety of music and food like pasta, burgers, salads, and Wolfie's famous buffalo wings with three varying flavors. But is that everything students are gibbering about? Wolfie's Restaurant is equipped with 6 servers, 2 bus boys, and 2 runners. The facility has about 32 tables and may seat up too 120 people. "We are staffed up, very busy every night," said John Pankovicia, Director for Wolfie's, the Union Deli, and Delancey Street. "Very few people have complained about the restaurant. Some people did not like certain items and exchanged it. We have regular restaurant problems," said Pankovicia. Since Wolfie's grand opening, it has been packed like sardines. "It's busy, but for the most part I like it," said Allison Godat, a waitress at the restaurant, while rushing anxiously to help her customers. The wait for a table at Wolfie's during nighttime has been irking to some. "We waited like 20-30 minutes", said Dimetri Lales, Senior, Mathematics Major. "Prices were ok, but they could have been cheaper, said Lales." Wolfie's has been compared to the old restaurant End of the Bridge. Michael Tsao, Junior, Business Management Major, furiously said, "The menu is half of what End of the Bridge had." "I don't think they put that much effort into the setting," said Tsao. "The lights are bad and they could have gotten a bigger place with more seating and meal choices. End of the bridge was bigger, had more seating, and the service was better and faster." Jackie Monroe, Junior, Journalism Major, waited desperately for her food for 25 minutes. After getting her food she finds out that the wings she received had been ice cold. After waiting, uneasily with hunger, for 8 more minutes she received a new plate. "My food was cold but when I finally got new wings it turned out pretty good," said Monroe. "The wait to pay was awful, but the atmosphere was really cool, plus the food was cheap."




#### Student Spotlight By:Mamusu Tucker

#### MTA proposes new fare increase

The MTA announced on Monday September 24, 2007 its plans to increase the fare to \$2.25. Talks will be taking place throughout December and if the fare increase is approved, it will take effect in late February early March. But wait! Don't be too alarmed, this fare increase may actually result in some riders paying less if they ride the train during off peak hours ...kind of reminds you of the Long Island Rail Road huh? If you ride the train during off peak hours you may be paying between \$1.50 and \$2.00. Unfortunately, this part of the proposal has yet to be approved.

#### Armed Freshman arrested on St. John's University Campus


Omesh Hiraman, a freshman at St. John's University was arrested Wednesday September 26, after he was spotted with a loaded rifle. Hiraman was wearing a mask at the time of his arrest. His arrest resulted in a campus lock down as the school sent out text messages notifying the students of the recent events. He bought the rifle last week in upstate New York. In his defense, his parents are saying that Hiraman was reacting badly to the medication that he was taking. He is said to be schizophrenic and has had on going mental illness due to the 9/11 attack. He is scheduled to undergo psychiatric evaluation in November to determine if he can stand trial. No one was hurt during this incident.


#### Mychal Bell free on Bail

As of September 27, 2007 Mychal Bell is free on bail after serving ten months behind bars for an incident involving five other Black students accused of beating up a White classmate. His bail was set at \$45,000. He is due back in court on Wednesday. But be advised, just because he is free on bail does not mean that the charges against him have been dropped. The judge said the charges still stand trial. Bell will now be tried as a juvenile. A Samaritan by the name of Dr. Stephen Ayers reportedly paid the required 12% of Mychal's bail. Avers said that he has followed the case and felt compelled to help. He goes on to stress that he isn't helping Bell because he thinks that he is innocent. He said that what Bell did was in "no way right and that he is not condoning his behavior, he just feels he needs to be punished appropriately."

#### Mos Def wants students to WALK OUT.


On October 1, 2007 Mos Def in conjunction with Talib Kweli, M-1 of dead prez, Malcolm X Grassroots Movement (MXGM), THE National Hip Hop POLITICAL Convention, Change the Game, SanKofa Community Empowerment, and other community organizations from more than 50 college campuses are advising all college students to walk out of their classes at 12 noon. They will be walking out in protest of the unfair treatment by Louisiana criminal justice system towards the 'Jena 6'. Their main demand was the immediate release of Mychal Bell, but as of September 27, Mychal Bell has been released from jail on \$45,000 bail. Their other demands include that all charges against the Jena 6 be dropped and for the immediate removal of the judge presiding over Bell's case.

#### MEGAN WILLIAMS: VICTIM OF CAPTIVITY, COERCION, AND CONTROVERSY By: Basira Lawal



On the 6th year anniversary of the terrorist attacks of September 11th another terrorist attack was reported on that date of this year. A young twenty-three year old Megan Williams was held against her will by six Caucasian adults; three men and three women. She was reportedly "sexually assaulted, stabbed, and tortured" for over a week. Although many of us today think racism has been eradicated through the Civil Rights Movement and prominent black leaders such as Martin Luther King, Jr., it still exists today. As students on the Stony Brook University campus, we fail to see these things because our campus is so diverse. In the case of Megan Williams, one of her kidnappers was reported to have stated "That's what we do to niggers around here."

It is rather saddening and astonishing to uncover such extremely hateful words coupled with the crime of hate. There also seems to be no substantial form of amelioration of these racist crimes against blacks. In a nation where we pride ourselves on "Liberty and Justice for all", we are incessantly forced to deal with direct contradictions of this phrase whose aim we have yet to achieve. This young lady is at the peak of her womanhood and they have attempted at destroying her physically, emotionally and mentally. They have usurped the one thing that levels her status of being a double minority; her pride. Being a woman and black is not necessarily difficult but it is an inevitable task many black women face as a part of their existence in the United States.

Megan Williams underwent extreme torture and humiliation; her hair was "pulled and cut", she had "bruised eyes", was forced to consume "dog and rat feces" and was "choked with a cable cord." This kind of story can bring tears to any woman's eyes because anyone can be a victim to unfair treatment regardless of the degree of it. However this is at the top of the line; this type of torture and hate was very excessive and inherently evil.

In the Trans-Atlantic Slave trade as well as during slavery times in America, the pastime of many Caucasian men was to pick an African-American woman he thought was suitable to sexually assault for his own pleasures. This idea clearly reverberates in the actions of these six Caucasian adults. To think that there were three women present at the time of this horrendous act, who could not stand up against this, is preposterous. However that is what makes it a hate crime. In the past Winter Study Abroad trip to Ghana, we visited Cape Coast Castle where the same ideas of torture and the sexual assault of women were explored. This is something that has been happening for ages and is still occurring today, in 2007; unfortunately.

Fortunately though, Megan Williams is still alive and confined to the boundaries of the hospital for some time before she can return to her normal life. And I use the word confine because the hospital system in America itself is a system which raises justifiable suspicion amongst the black community in the United States. There is a deep-rooted mistrust for health facilities because of a past experience such as the Tuskegee Syphilis Experiment where 399 men were left to die of Syphilis not knowing that they were suffering from it. The Public Health Service used these men as human laboratory animals and told them they were testing them for "bad blood." One of the doctors reported that "[They] have no further interest in these patients until they die."

Williams' case takes us back to this and also the time when Jim Crow laws regulated American life. This continuous subjugation of African-Americans in an effort to prove superiority is still an issue. Comprising 12% of the United States' population, how much

power do African Americans have? And if we possess any power how can we utilize it to put a stop to these blatantly indecent actions against blacks?

### A MOVEMENT THAT WON'T STOP!!!!? By: Saajida Stacker

Come with me as I take a little trip down memory lane and briefly discuss main events that have left primarily the Black and Hispanic communities temporarily damaged and the people in distress. Do you remember in 2005 the tragedy of Hurricane Katrina? I hope we all still remember what took place in the town of Jena, Louisiana with "Jena 6". How do we get away from all of this? What do we do? Should we just accept these injustices and catastrophes as apart of our lives? Do Nothing or Do Something? Does anyone have an answer to the question, what must be done?

The aftermath of Hurricane Katrina devastated New Orleans' residents in 2005. After the Hurricane many thought that the worse was behind them. This was not the case! Many black people were stranded on rooftops and without food for days. Eventually, some help arrived but I guess they started in a different part of town first. The black and the poor were left to be rescued last on the list after the rich, privileged, and even dogs. Imagine being left stranded, not knowing what you're waiting for or how long you have to wait for a rescuer team to save you and your family. What a traumatizing experience to watch dead bodies as they float by you in the water, people crying, and waiting on rooftops. Most of us would say enough is enough, I'm going to take matters into my own hands just like most black people did who started to wise up when they came to the realization that no one's coming or if they decide to come it will be too late. Men, women, and children who were determined to survive were labeled as "looters", "animals", and "refugees" in the media. According to the Information Clearing House website Michael Parenti writes, "By Day Three even the myopic media began to realize the immense failure of the rescue operation. People were dying because relief had not arrived. The authorities seemed more concerned with the looting than with rescuing people. It was property before people, just like the free marketers always want". Now let's be real, what would you do if you were in this situation? Would you just sit and wait peacefully for someone to come?

Jena, Louisiana along with others has also encountered injustices from society. Jena 6 is a name that was given to the six black boys (Mychal Bell, Theo Shaw, Robert Bailey, Carwin Jones, Bryant Purvis, and Jessie Beard) who were arrested on December 4, 2007 for beating up a white student (Justin Barker) at Jena High School. Two of the young men are being charged with second degree attempted murder and the Court's originally wanted to trial Bell as an adult, even though he was a juvenile at the time of the fight. But absolutely nothing was done about nooses being hung from a white tree on the campus of the high school. This act was brushed off as a prank. When black students sat under the tree in protest, According to Advocacy Organizations, "The District Attorney then came to the school accompanied by the town's police and demanded that the students end their protest, telling them, "I can be your best friend or your worst enemy... I can take away your lives with a stroke of my pen." By putting up those nooses the white students were participants in a hate crime. Should they not be put on trial for that? Is this justice? Let me know!

So, I ask what must be done? Should we depend on others to give us justice, to help us when we are in need? I think through the previous examples and many others it has been proven that we can no longer wait for people who don't care about us and don't have our best interest at heart to assist us in dire emergencies. Can we depend on anything/anyone?

The Honorable Minister Louis Farrakhan again called people to Washington, D.C. to participate in the 10th Anniversary of the Million Man March on October 15, 2005. This was a call for millions of Black, Native American, Hispanic, Asian, and White people to come together not just to march but to set the foundation for a movement. This event is called the Millions More Movement. The Millions More Movement was not a day long event and then we go back to business as usual; for it is still continuing to this very day.

What is the Millions More Movement all about? Under the Millions More Movement leaders in education, religion, hip-hop, politics, economics, health, etc. has come together putting their differences aside in order to focus on a common goal. The goal is to improve the lives of those who reside in poor rejected communities. The Honorable Minister Louis Farrakhan states in an interview, "We can no longer depend on a benevolent President to correct our condition, that is a responsibility that we must take on our own shoulders...". He has spoken to many individuals and organizations about this movement and has gotten support from different people who agree that the poor need to do for themselves because there is strength in numbers. Farrakhan states in a letter he wrote, "The agenda of the Millions More Movement [is] to... direct our energy... at the condition of the reality of the suffering of our people, that we might use all of our skills, gifts, and talents to create a better world for ourselves, our children, grandchildren, and great grandchildren".

Members and supporters of the MMM are people such as Rev. Jesse Jackson, Russell Simmons, Erykah Badu, India Arie, Rev. Al Sharpton, Dr. Conrad Worrill, Dr. Dorothy Height, Kanye West, and many others. Under the banner of the Millions More Movement there are committees called Local Organizing Committees (LOC) set up in many states. Bettering our communities is not an over night thing; it's going to take all of those who want to make a change for their future to participate in some way. Therefore, if you want to make a change... don't talk about it, be about it; do something!

The Honorable Minister Louis Farrakhan (Convener of the MMM), Rev. Willie Wilson (Director of the MMM), and other leaders of the MMM in 2005 were starting a protest effort against FEMA because they planned on evicting 150,000 American citizens who were victims of Hurricane Katrina from hotels and temporary housing. The MMM has also assisted with the preparation for the National Protest and Rally on Sept. 20 in Jena, Louisiana. Mychal Bell's father, Marcus Jones said, "I appreciate....the Millions More Movement for everything you all have been doing". Marcus and Melissa Bell were guests of Minister Farrakhan on Sept. 16 at Mosque Maryam in Chicago during a national webcast lecture. There are nine ministries being developed; some are the Ministry of Education, Health & Human Services, Finance, Justice, Arts & Culture, Agriculture, Technology, etc. The ministries are being developed by qualified persons and volunteers to assist those who may need assistance in these fields. As we have seen with Hurricane Katrina and Jena 6 we can't rely on those who only care about the rich, privileged, and those with power to help us. Therefore we must set up something where we can help black people and others who are often-times cast aside. The Millions More Movement is the answer!



#### Jena Six Rallies Takes Place Close To Home By: Jahlecia Smith

On September 20, a demonstration in support of the Jena Six was held on Staten Island. In attendance were clergy members, local politicians, and the Staten Island chapter of the National Association for the Advancement of Colored People (NAACP). The political leaders at this rally spoke out against the inequalities in the justice system. They joined together at Borough Hall to rally against what they call "the double standard of the prosecution of blacks and whites."

In Bergen County, New Jersey, African American leaders and community activists gathered inside Mount Olive Baptist church to protest the treatment of the group of teens popularly referred to as the Jena Six. Protestors at this rally were stressing that "unequal justice is not just limited to Jena. Cases are also present in New York and New Jersey." The residents of Bergen County hope that through song and prayer, similar acts of injustice can be stopped before they occur.

In Brooklyn, New York, hundreds gathered at City Hall to show support for Louisiana's Jena Six. In attendance were religious leaders and community activists. Brooklyn borough president Marty Markowitz said that "this case proves that the ugliness of racism and discrimination still have the potential to divide us.... it's time for us to deal with a justice system that only works half of the time for some of the people." On September 18, at Stony Brook University, Alpha Phi Alpha Fraternity, Incorporated led a rally to protest the unfair treatment of the Louisiana teens deemed the Jena Six. Samuel Darguin, a prominent speaker on the Stony Brook campus was quoted as saying that "it was not just a rally but a movement." After the initial gathering in the Student Activities Center, the protestors moved outside to participate in a march.



#### Is the Jena Six Case a Racist Issue? By: Jahlecia Smith

Before you can answer this question you must first look at this case from numerous perspectives. Is this case a racist issue due to the extent of the criminal punishment administered to the individuals? Or is it a racist issue due to the race of the individuals involved? Would this case be considered a racist issue if it were six white males sentenced to jail for attempted murder as a result of a schoolyard fight? Or would that punishment be justified if it were six white students who were beaten unconscious? There is so much controversy surrounding this case that I can only do it justice by starting from the beginning.

On a September day in 2006, Kenneth Purvis, a black student, approached the school's Vice Principal and asked if it was alright for him and his friends to sit under a tree in the schoolyard, a tree that was designated at the school as a "white tree," which was located on the side of the school courtyard where the white students congregated. The Vice Principal said that it was alright and the boys proceeded to sit under the tree. The next day, students arrived at the school to find three nooses painted in the school colors hanging from the tree. Feeling angered and threatened, Bailey and his friends reported the incident to the school officials. The nooses were removed and the school took disciplinary action against the three white students who were guilty of placing the nooses on the tree. The students were originally to be suspended from the school for the remainder of the school year, but the decision was overturned by members of the school board. The punishment was reduced to a three day suspension and the incident was passed off as a prank, as if to say the symbolism behind a noose could be used as material for comedy hour. Outraged, the black student body at the high school staged a peaceful protest. In response, the school called in District Attorney Reed Walters. District Attorney Walters addressed the black students and allegedly threatened them by saying "I can make your lives disappear with the stroke of my pen." In the days that followed, the same young men who sat under the tree soon began to find themselves placed in a series of racially fueled incidents.

One of the boys, Robert Bailey was invited to a party by a group of his white friends. A party that, unbeknownst to him, was reportedly deemed an "all white affair." When Bailey entered the party he was punched in the face by a white male. Bailey said that his attackers even broke beer bottles over his head. The only problem with this accusation was that Bailey did not have any hospital records reporting such an injury. The morning after the incident, Bailey and his friends were leaving a local convenience store when they ran into one of the men that attacked Bailey the night before. They say that the white male went to his truck and pulled out a pistol. Bailey and his friends were able to wrestle the gun away from the white male and reported the incident to the police. The police responded by charging Bailey and his two friends with theft of a firearm and second-degree robbery.

Three days after this incident, tension between the white students and black students reached a breaking point. On December 4, 2006 Bailey and five of his friends, Theo Shaw, Carwin Jones, Bryant Purvis, Jessie Beard, and Mychal Bell were accused of beating up a white student by the name of Justin Barker. Unfortunately, information pertaining to the cause of the fight is very sketchy. But, what is repeatedly reported is that Justin Barker was taunting Bailey about getting beat up at the party. Barker is said to have been hit from behind and knocked unconscious. He suffered a concussion and had injuries to his eyes and ears as well as cuts and bruises. He was taken to the hospital in an ambulance, treated and held for two hours, and released. The same night after the fight, Barker attended a school ring ceremony. In his defense, he said that "he waited four years of High School to attend his ring ceremony and he was not going to miss it." After the fight, Bailey and his friends were charged with attempted murder. Their charges were later reduced to second degree aggravated battery and conspiracy, which, if convicted, could land them up to twenty years in prison. Now coming back to the previous question, is the Jena Six case a racist issue?

If you look at how the Louisiana court system responded to the case, then yes, it is. The punishment dispensed to the six black students did not fit the crime. These boys were initially facing up to life in prison as the result of a schoolyard fight. If you look back towards the incident of the nooses being hung from the tree, the punishment the three white students faced were nowhere close to the criminal punishment they should have received. The noose incident was taken lightly, which the black students saw as a slap in the face. One of the boys, Mychal Bell whose initial bail was set at \$90,000 is the only one of the Jena Six to stand trial as of yet. He was convicted by an all white jury in June and could have faced up to 22 years in prison. Considering the racial make-up of Jena, Louisiana, it is no surprise that Bell's jury took less than three hours to deliberate. The town of Jena is said to be one of the areas "bypassed by the civil rights movement." Blacks only make up about thirteen percent of the total population. Just hours after the recent rally to free the Jena Six, two white men were arrested in the nearby town of Alexandria for dangling nooses from their trucks. Though Bell was initially tried as an adult, the conviction was thrown out because he was a juvenile at the time of his arrest. His case will now be tried in juvenile court. The other five students have yet to be arraigned on their charges. This case has been around for over a year but it just now getting media attention. The media's slow response to the Jena Six case is telling. Most mass media stations are unwilling to tackle the issue of racism. They would rather show us Brittany Spears' latest endeavor than broadcast the unequal treatment in the justice system. And if you're wondering what our president has to say about the race relations in Jena, Louisiana...He is quoted saying that "The events in Louisiana have saddened me. I understand the emotions. The Justice Department and the FBI are monitoring the situation down there...All of us in America want there to be fairness when it comes to justice." He then goes on to advise whoever is elected next year to "reach out to the African-American community." It's good to know that our president is "saddened," but he leaves no doubt that he will not get involved. The war in Iraq has not shifted to Louisiana and neither will his interest.



# NEWS BEYOND THE BROOK



#### I **PIP IT**By: Marc Jacques

On September 16, 2007, O.J. Simpson was arrested and charged with 11 felony counts following the alleged armed robbery of sports memorabilia in a Las Vegas hotel-casino. Simpson claims that he did not do anything wrong; he was simply taking back what was rightfully his. He was released on bail and is scheduled to reappear in court in October.

Simpson has run into a brick wall of charges. Among them are two counts of first degree kidnapping with use of a deadly weapon, two counts of robbery with a deadly weapon, and two counts of assault with a deadly weapon. He was also charged with coercion and conspiracy to commit a kidnapping and robbery. If he is found guilty for these charges, he may be facing life imprisonment. Simpson was released on September 19 after paying bail of \$125,000 and agree-ing to abide by certain conditions. The court stipulated that he must refrain from communicating to any of the alleged victims, witnesses, or co-defendants. Simpson will be arraigned on the week of October 22 and according to his attorney, Yale Galanter, he will be pleading not guilty.


The incident happened because Simpson, who was in town for a wedding, received news of his alleged items being sold by a sports memorabilia dealer, in a room at the Palace Hotel-Casino. Simpson assembled a group of his friends and raided the dealer's hotel room. The group allegedly robbed the dealer at gunpoint. They left with the memorabilia and took some of the dealer's possessions. The event was recorded on an audiotape which contains Simpson shouting to his posse, "Don't let nobody out of this room". He also yells at the dealers for stealing

his things and trying to resell them. Simpson does not deny barging into the dealer's room. Furthermore, Simpson believes that he did not steal anything.

Since his major trial, Simpson has had a few minor encounters with the police, but he has managed to keep his name off the headlines. He started getting the media's attention pending the release of his ghost-written book and because of a court case which resulted with the Goldman family as sole owners of the book. The book entitled If I Did It: Confessions of the Killer is what Simpson claims to be a hypothetical description of how he would have committed the murders of Nicole Brown and Ronald Goldman. Ironically and coincidentally, his book became a best-seller the same week as his run-in with the law. That week it climbed to the number one selling book on Amazon.com and at Barnes & Nobles.com. The book has sold so many copies that the publishers have decided to do a second print of an additional 50,000 copies.

Twelve years ago, Johnny Cochran told the jury in the double-murder trial, "If the glove doesn't fit, then you must acquit." Now Simpson is back in court for different charges. The founder of the Choices foundation said Simpson may defend himself by saying, "The theft is fine, if the stuff is mine."

There has been heavy criticism leveled at BET (Black Entertainment Television) and the creators of "Read a Book," rapper Bomani "D'Mite" Armah and director Tyree Dillihay. Critics argue that the video portrays Blacks in a negative light, while Armah responds that the video is a parody of hip-hop videos. The debate is heated enough that it has provoked the ire of Jesse Jackson of the "Keep Hope Alive" radio show and Reverand Delman L. Coates of the Enough is Enough Campaign.

"Read a Book" is an animated video in the style of popular rap videos, and as such includes the usual foul language, gun toting gangstas, and women gyrating their behinds. BET, began airing the video this summer, but the debate over its images and lyrics intensified when an unedited version appeared on YouTube. The New York Times reports that Denys Cowan, senior vice president of animation for BET, said in an interview in August, that the video is "meant to be very satirical, and in a real way kind of mimics and mocks the current state of hip-hop and hip-hop videos."

The video begins in the auditorium of a "ghetto" high school with the cartoon figure D'Mite playing "Beethoven's Fifth Symphony" on a piano in front of a Black audience. As D'Mite raps about the need for the ghetto community to "read a book, raise your kids, drink water, buy land, brush your teeth, and wear deodorant," the images depicted in the cartoon are stereotypical images of Black men as criminals, lascivious Black women who jiggle their behinds and get spanked by Black men, and even an image of Africans from the "Dark Continent" dancing around a fire.

Those who criticize the video take offense at the fact that the video implies these images represent the Black community. In a CNN interview, Armah, who states he talks with young people about how hip-hop affects their lives, contends that "Read a Book" should be viewed as a criticism of derogatory hip-hop videos, and not as a representation of Black folks. However, critics raise the issue that the images in "Read a Book" are primarily black images, and the only two white images are figures of authority. The outrage over the video has led more people to join Coates' in protesting the entertainment industry capitalizing on derogatory and demeaning images of people of color. Coates points to the ties between the negative representations of non-whites, the injustice seen in cases like the Jena Six, and the increasing incarceration of Blacks and Latinos. Enough is Enough targets not only the rap and hip-hop artists, but the sponsors of the shows in which they appear, as well as the corporate executives of the industry. For the past four weekends, the campaign has been holding rallies outside the Washington, D.C. home of Debra Lee, the chief executive of BET. Now the movement is expanding into New York City, and this weekend, on Saturday, October 13, the first rally will be held at a location in New York City that is undisclosed at this time. BET under Viacomm has increased its budget and aims to increase its maturity. Reginald Hudlin, the president of entertainment of BET, is quoted in a Washington Post article as describing the line up for this season as "the largest aggregation of original programming about black life in television history." Meanwhile BET continues to air the controversial video and has not removed the unedited version from the internet. In response, the host of Uprising radio, Aura Bogado, suggests that if BET wants to send a positive message, why not air conscious hip-hop videos.

#### WHY??? By:Kristina Negri





#### "What's your Flavor?" By: Sarah Demezier


Imagine you are on the back of the bus on your way home and there is a couple holding hands. Your immediate reaction would probably be "How cute?", but what if the couple consisted of a Black male and an Asian female, would you still say "How cute?", or would you stare in disbelief? Many people usually react by staring because they are not used to seeing people of different race or culture dating. Shouldn't our society, as diverse as it is, be able to accept interracial dating? Sadly that isn't always the case.

Miscegenation is the "mixing" of different races whether the individuals are married or sexually involved. Interracial dating, which is related to miscegenation, has become a very big issue in today's society, restricting many people to date within their race. Going back into history interracial dating wasn't favored and was a very serious offense. Anti-Miscegenation laws were enforced in the United States, predominantly in the south, in the year 1913. Although they were later declared unconstitutional in 1967 many states in the south still continued to punish those who married someone out of their race. When these laws were in effect anyone found guilty of miscegenation were often imprisoned.

Although college is usually a place where you can find interracial dating, it wasn't always that way. Bob Jones University in South Carolina banned interracial dating on campus in the 1950's. The main reason for this ban was because they believed that God separated us by race for a reason and that we should remain that way. That ban was later lifted and now it is much more common to see people of diverse cultures dating. In this generation the center for interracial dating is in college. College is where you are introduced to many cultures and because of the amount of diversity you are bound to date out of your culture. Even though it is more common to date someone of a different race on a college campus, it is less common that it will lead to marriage. Anti-miscegenation existed because of the many factors that hinder it to be supported. Factors such as religion but the most significant one is culture.

Culture is a part of everyone and since there are so many different kinds of beliefs and values it is harder to compromise between individuals of different cultures. For example, a Muslim female is dating a Hispanic male who eats pork. She doesn't eat pork because of her culture but his staple diet is pork. There is no real way to compromise since her religion is very strict. On Tuesday night in the Union Auditorium the sisters of Epsilon Sigma Phi hosted "Dating outside the Lines," a presentation on the affects of dating outside of one's culture. This very informative session focused on clearing up the many myths of interracial dating.

The five myths are very much known to many as true but in fact they truly are just a figment of our imaginations. Myth one, there are many interracial marriages. In actuality there are far less interracial marriages, statistics show that in the year 2002 out of 57, 919 marriages only 1,674 were interracial. Myth three, you can't be racist, you can still be racist against someone even if you are dating out of you race. Myth four, I found very funny, that interracial dating is a trend related to fashion. The only people that are more subtle about miscegenation are family and those within your race.
