


CHAPTER ELECTIONS TO BE HELD THIS SPRING

In the coming months, the UUP Administration Office in Albany will conduct elections for all Stony Brook chapter officers and delegates. Candidates will be sought for president, vice presidents for academics and professionals, grievance officers for academics and professionals, secretary and treasurer. In addition, thirteen academic and professional delegates will be elected to represent Stony Brook at the three statewide Delegate Assemblies held each year.

An election committee comprised of William Fox (2-8278), Barbara Sewell (2-6965) and Janet Steins (2-7150) has been charged with recruiting candidates. If you think you might be interested in serving in one of these positions and want additional information, contact one of us. The union supports chapter leaders by holding annual leadership workshops, usually in the Lake George area of the Adirondacks.

A call for nominations will be sent to all of us soon, and you may respond directly with your name or with the name of another candidate - there is no requirement to go through the committee to nominate yourself or others. It is, however, essential that you make sure the nominee is willing to serve before submitting any name. All candidates must be UUP members; Agency Fee payers are excluded.

MILEAGE RATE INCREASE

UUP Treasurer John Hunt has announced that as of November 21, 1988, all mileage will be reimbursed at the newly announced IRS rate of 24 cents per mile. Vouchers will be adjusted to reflect the new allowance.

Should you be dissatisfied with the assistance or service provided by the HBA on campus, call the UUP Administrative Office in Albany (800/342-4206 or 518/458-7935). Ask for Stanley Wojtowicz, UUP's Benefits Specialist. While UUP is not yet a full partner in the administration of the State Health Insurance Plan, we have "carved out" a consumer advocacy role and can be helpful in many cases.

NEW NYS ETHICS IN GOVERNMENT ACT MANDATES FINANCIAL DISCLOSURE FOR SUNY EMPLOYEES EARN-ING MORE THAN \$30,000

As of January 1, 1989, all New York State employees earning more than \$30,000 (some 50,000 of usl) are required to file full financial disclosure statements, and we have until May 15 to do so. This time lag is supposed to give the Ethics Commission time to whittle down the list of workers required to file the forms, which will cover income, bank accounts, investments and loans involving us, our spouses, and dependent children.

UUP President Tim Reilly has testified before the Ethics Commission, arguing for exemption for SUNY employees. The Commission is currently preparing guidelines to exempt entire categories of state and authority workers who do not make policy. President Reilly argued that to include higher education faculty is a misapplication of the spirit of the ethics legislation, and that safeguards already exist against improper professional behavior. There is no doubt that if SUNY faculty members are not exempted from this disclosure requirement, recruitment of top faculty will be adversely effected.

The New York State Government Integrity Commission, usually a strong proponent of full disclosure, recently criticized the "absurdly excessive" disclosure procedure, which would "impose onerous burdens on tens of thousands of

LONG TERM CARE INSURANCE OPTIONS - INFORMATION NOW AVAILABLE

The chapter office has available an outline of Individual Long Term Care (custodial care) Insurance Policies available for purchase in New York State. You may request a copy of this information, researched and prepared by Sally Lieberman in the UUP Benefits Department, by calling Joe Weitzner at 2-6570. The NYSUT \$2,000,000 catastrophe plan, available through payroll deduction, also has a three year long term care (custodial care) benefit. UUP makes no recommendation to purchase this insurance nor claims that any one policy is better than another.

We should all take note that while Medicare recently added elements of catastrophic coverage to its benefit levels, long term custodial care is still only available after one "spends down one's assets" to be eligible for Medicaid. Also, there are no health insurance plans, that we know of, that provide this coverage, including our own Empire Plan/HMO's.

However, there is a growing sense that in our state, as well as nationally, this is a growing problem that must be addressed. Presently, the Congress has established a commission to prepare a report with recommendations to the Congress of how this coverage should be provided.

LINK SCHOLARSHIPS AWARDED

At February's Winter Delegate Assembly in Albany, UUP awarded the first Eugene P. Link Scholarships. The winners were Scott Benjamin of SUNY Oswego and Kevin Days and Marjorie Millea of SUNY Plattsburgh.

The Link Scholarship is awarded to undergraduates who exhibit the same qualities shown by one of UUP's founding members, Eugene Link. The retired Plattsburgh history professor, who taught for 35 years, and veteran union activist is remembered for his devotion to the pursuit of knowledge, service to SUNY and the community, and leadership in academic unionism.
