DISCRETIONARY SALARY ICREASES A MESSAGE FROM YOUR EXECUTIVE BOARD

The UUP contract provides that 1% of combined annual salaries of all members of the bargaining unit is held for distribution at management's discretion. UUP has no say in the actual distribution of DSI. Basically, it is the prerogative of the campus president, guided by administrators.

Despite repeated overtures to assist DSI policy, we have no input. Our recommendations have gone unheeded. Consequently, we feel it is necessary to present our views so that the membership can assess our position. Your feedback is encouraged.

We know that DSI decisions are necessary for each year of the contract. Our premise is that unit heads should tell all UUP -unit employees well in advance to present their case if they wish to be considered. All faculty, librarians and professionals are eligible; all MUST be treated the same way.

Procedurally, each unit should have a committee - chosen anew each year- to advise its department administration regarding DSI decisions.

Stony Brook's management has failed to formulate a policy to balance merit, inequities and salary compression. Nor has it attempted to define merit. UUP advocates a "pool" distribution method that addresses both equity and merit.

Though all members of UUP must be eligible, we believe that individuals receiving extra pay as well as those in the top 10% of salary ranks could be especially screened; approved by their unit and then endorsed by a campus committee. We believe that it is unconscionable to use DSI funds to cover raises that are needed to match external offers.

The campus president can raise a salary at any time; DSI is not provided for such purposes. Often the call for individual petitions comes during vacation, and/or at different times in different units and between faculty and professionals. This is a shoddy practice that is easy to remedy with established criteria and a fixed timetable. Current practices increase the atmosphere of mystery and disquiet about inequities and cronyism that plague SUNY over this small sum of money.

If you are not happy with the way your department head and/or unit manager have dealt with the DSI process, call the office of the president or Director of Human Resources.....not the UUP. We have no hand in what goes on with DSI and have been unsuccessful in gaining clarification of the policy and procedures that inform campus practice.



In The Spotlight... Charles Hansen 2000 Nina Mitchell Award Recipient

We are pleased and proud to announce that one of our own will be honored for his distinguished service to UUP later this month during the Fall Delegate Assembly in Buffalo. The award he will receive was named in honor of Nina Mitchell (1926-1988), a veteran union activist from Brooklyn HSC, and is considered our Union's highest honor.

A pioneering member of the union's predecessor organizations - State University Professional Association (SUPA) and the Senate Professional Association (SPA) - Hansen is considered by his chapter nominators to have an "unwavering agenda to make faculty and professionals equal partners in the eyes of SUNY and state managers."

In the early days, that was easier said than done. Professionals were, by all accounts, hired and fired at the whim

Dear Bonnie

If I am called to a meeting with my supervisor, or someone else in the supervisory chain or campus police, which I feel may lead to a disciplinary action, what are my contractual rights?

ANSWER:

UUP recommends that you contact the union BEFORE attending the meeting in question. You have a right to representation, whether it be from your own attorney or from a union representative. While you may be inclined to rid yourself of the guilt you may be feeling by admitting and even signing a written confession, you may have, in the process, waived a very important part of your right to due process under the con-

Article 19 of the Agreement between the State of New York and UUP specifically deals with the subject of discipline. Upon review, you will notice many protections for employees that allow specific periods of time for you to contest a disciplinary notice. In order to comply with these timeframes, it's imperative that you contact the union office as soon as you receive a notice to appear at a meeting that may lead to a disciplinary action. The clock starts ticking, and we must do all we can to protect your rights and work towards the best possible outcome for you. We're here for you-call us and allow us to be of assistance.

("In The Spotlight" continued from page 3) of managers. As assistant director of business management at the Graduate Physics Facility, Hansen fought to change that.


In SUPA, he served as a delegate and on several committees. When SPA evolved as a hybrid organization to encompass both academic and professional faculty, Hansen was called to serve as his chapter's first president and, later, as vice president for professionals. He is still a UUP delegate.

"No one worked harder for union issues than Charlie Hansen," his nominators said. "His vision of and for the union has led to a sense of importance and belonging that many members feel today. Every professional today has been positively affected by Charlie's vision three decades ago."

Hansen was UUP's vice president for professionals in the early '80s and served for three years on the Executive Board. He has also been a member of the Negotiations, Career Development, Membership, and Active Retired Membership committees.

We do not live solely in the present. We stand on the shoulders of those who, like Charlie, built the foundations on which our organization stands. We are deeply grateful for his contributions, both to our Chapter and Statewide, and will applaud loudly as he is recognized at the Fall DA with this award.
