UPDATE ON FINANCIAL DISCLOSURE

The State Ethics Commission recently provided UUP with three lists of SUNY job titles in response to the union's request that the commission straighten out the mass confusion which resulted in their sending their "Notice of Failure to File Financial Disclosure Statement" in the middle of October to many of us who thought we were either exempt or on hold.

ACADEMICS

ALL academic titles are ON HOLD and are still being reviewed by the Commission. The Commission will determine, at some future date, whether any or all of these titles will have to file Financial Disclosure Forms. Until that determination occurs no one in these titles has a duty to file.

If you are an academic and received a Notice of Failure to File....., forward to the UUP Office, 104 Old Chem, a copy of the notice, along with your SUNY title and social security number. We will be sending these up to the UUP central office in Albany. We also recommend that that you send a copy of your notice back to the Commission with the following notation on it: "My SUNY title is _____ and appears on the SUNY Academic Titles: On Hold list." A copy of this list is attached for Academics.

PROFESSIONALS

The Ethics Commission has provided us with two lists of Professional titles; copies are attached for Professionals (EXCEPT that in the interest of saving time and paper we have not duplicated that section of the long list of UUP exempt titles which refers to T.H., or Teaching Hospital, professionals since these people are are not in our chapter; in this specific sense this specific list is incomplete).

The first, "UUP Non-Exempt Titles," represents 27 titles which are under an absolute requirement to file the Financial Disclosure Form and have, or should have, known this fact since last June.

The second, "UUP Exempt Titles," represents titles which have been declared exempt from filing the Financial Disclosure Form by the Ethics Commission itself. If your title is on this exempt list and you received a Notice of Failure to File...., forward to the UUP Office, 104 Old Chem, a copy of your notice, along with your SUNY title and social security number. We will be sending these up to the UUP central office in Albany. We also recommend that you send a copy of your notice back to the Commission with the following notation on it: "My SUNY title is _____ and appears on the July 18th UUP Exempt Titles list."

UUP IS AWARE THAT SOME PROFESSIONAL TITLES DO NOT APPEAR ON EITHER OF THESE TWO LISTS. The union is seeking to determine from the Commission whether people in this "limbo" status must file or not. You will be notified as quickly as possible of the Commission's response. If your title does not appear on either of the lists and you received a Notice of Failure to File....., forward to the UUP Office, 104 Old Chem, a copy of your notice, along with your SUNY title and social security number. We will be sending these up to the UUP central office in Albany.

UUP has been informed by the chairperson of the Ethics Commission that there will be a delay in the 15 day requirement in order to straighten out the errors that have been made. Hopefully the Commission will issue a public statement on this delay shortly.

Finally, the 1987 Ethics in Government Act has been amended at the recommendation of the Ethics Commission. In addition to numerous technical corrections and clarification, the legislature agreed to raise the income threshold from \$30,000 to the job rate of SG 24 (currently \$50,396) for persons who must file the annual financial disclosure form. Tying the threshold to a salary grade rather than a dollar amount will allow for annual increases in this threshold without amending the legislation. In April of 1990 the cutoff for filing will automatically increase to \$53,174. Individuals earning income below the threshold who hold policy making positions may still be required to file the financial disclosure forms. The new income threshold will take effect January 1, 1990. The law specifies that the \$30,000 cutoff will remain in effect until that date.
