## NYS Flex Spending Account 2007 INFO (DEADLINE Nov.10th, 2006)

The NYS Flex Spending Account (FSA) has two types of benefits you can enroll in for 2007. They are the Health Care Spending Account (HCSA) and the 2nd is the Dependent Care Advantage Account (DCAA). You can enroll in either or both of these benefits with a deadline for next year of November 10th, 2006. HCSA lets you set aside any amount from \$100 up to \$4,000 annually to pay for health care expenses that are not reimbursed by your health insurance or other benefit plan. However, only medically necessary medical, hospital, dental, vision, hearing and prescription drug expenses for you, your spouse, and your eligible dependents can be reimbursed by your HCSA.

DCAA allows your family to set aside up to \$5,000 in pre-tax salary for eligible child care, elder care, or disabled dependent care expenses that are necessary for you and your spouse, (if you are married) to work. As a result of collective bargaining, you will be eligible to receive an Employer Contribution to your DCAA based on your salary any where from \$200 to \$700.
