Die in diesem Hefte veröffentlichten neubabylonischen Kontrakte — fast ausschliesslich Naturalien betreffende Geschäftsurkunden aus der Zeit von Nabopolassar bis Darius II — wurden von Herrn Dr. UNGNAD kopiert und autographiert. Die Anordnung ist chronologisch, nur ist Nr. 215 hinter 177, 232 hinter 163, 168 hinter 172 einzuordnen. Eine chronologische Übersicht aller neubabylonischen Kontrakte des Berliner Museums bleibt einem späteren Hefte vorbehalten.

Angaben über Grösse und Farbe der Tontafeln unterblieben absichtlich, weil ohne praktische Bedeutung. Die durchschnittliche Grösse der Kontrakte bewegt sich zwischen  $3 \times 4\frac{1}{2}$  und  $5 \times 6\frac{1}{2}$  cm. Wie geringen Wert aber die Farbe für die Bestimmung der Zusammengehörigkeit einzelner Bruchstücke hat, lehren z. B. die drei vereinigten Fragmente VAT 1933 + 1936 + 2074, von denen das erste (mittleres Stück) rotbraun, das zweite graubraun und das dritte schwärzlich braun ist.
